What does the Fund invest in?

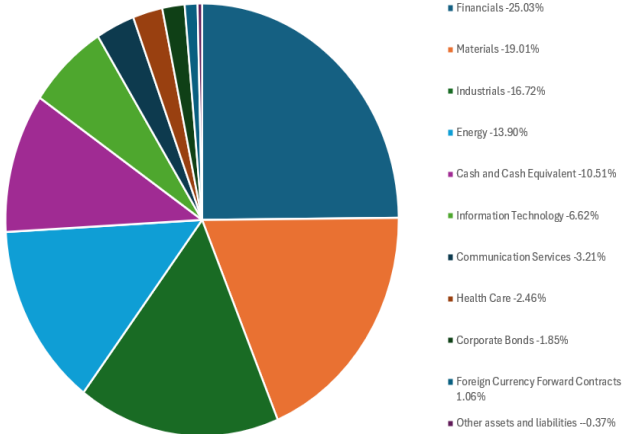
The Fund seeks to generate income and long term capital growth by investing in a combination of equity and fixed income securities of issuers located anywhere in the world, including those in emerging markets. Exposure may be from any combination of holding such equity and fixed income securities, investments in other mutual funds and derivatives.

How risky is it?

The value of the Fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund’s restores change over time. This is called “volatility”.

In general, funds with higher volatility will have returns that change over time. They typically have a greater chance of losing money and may have a chance of higher returns.

Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

Risk rating

Barometer Capital Management Inc. (“Barometer”) has rated the volatility of this Fund as **medium**.

This rating is based on how much the Fund’s returns have changed from year to year. It does not tell you how volatile the Fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

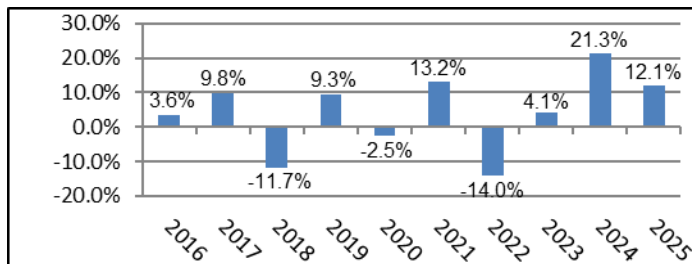
Like most mutual funds, this Fund does not have any guarantees. You may not get back the money you invest.

How has the Fund performed?

This section tells you how Class A units of the Fund have performed over the past ten calendar years. Returns are after expenses have been deducted. These expenses reduce the Fund's returns.

Year-by-year returns

This chart shows how Class A units of the Fund performed over the past ten calendar years. The Fund dropped in value in three of the past ten years. The range of returns and change from year to year can help you assess how risky the Fund has been in the past ten years. It does not tell you how the Fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Class A units of the Fund in a 3-month period over the past ten years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

The annual compound return of Class A units of the Fund was 3.95% over the past ten years. If you had invested \$1,000 in the Fund on January 1, 2015, your investment would now be worth \$1,474.05 as of December 31, 2025.

Who is this Fund for?

Investors who:

- want to invest for the long-term (in excess of five years)
- have a need for regular monthly distributions
- are seeking global equity and fixed income exposure for their portfolio

There are no criteria for holding Class A units of the Fund, anyone in the Provinces of Canada may purchase Class A units of the Fund through their representative.

A word about tax

In general, you'll have to pay income tax on any money you make on the Fund. How much you pay depends on the tax laws where you live and whether or not you hold the Fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold the Fund in a non-registered account, Fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class A units of the Fund. The fees and expenses - including any commissions - can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other classes of units and other funds that may be suitable for you.

1. Sales charges

The Class A units of the Fund are available through an initial sales charge option.

Sales charge option	What you pay		How it works

Initial sales charge	0% to 5% of the amount you buy	\$0 to \$50 for every \$1,000 you buy	You and your representative decide on the rate. The initial sales charge is deducted from the amount you buy and it goes to your investment firm as a commission.

How much does it cost? (cont'd)

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the Fund's returns. As of June 30, 2025, the Fund's expenses were 3.49% of its value. This equals \$34.90 for every \$1,000 invested.

Annual rate (as a % of the Fund's value)	
Management expense ratio (MER) This is the total of the Fund's management fee (which includes the trailing commission) and operating expenses.	3.08%
Trading expenses ratio (TER) These are the Fund's trading costs.	0.41%
Fund expenses (MER + TER)	3.49%

The Fund may also pay an annual performance fee to the portfolio manager, equal to 20% of the amount by which the value of the Fund exceeds the value of its benchmark.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the Fund. It is for the services and advice that your representative and their firm provide to you.

Barometer pays a 1% trailing commission to your representative's firm. It is paid from Barometer's management fee and is based on the value of your investment.

Sales charge option	Amount of trailing commission

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the Fund.

Fee	What you pay
Short-term trading fee	Up to 2% of the value of units you sell or switch within 90 days of buying them. This fee goes to the Fund.
Switch fee	Your representative's firm may charge you up to 2% of the value of units you switch to another

What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- Withdraw from an agreement to buy mutual fund units within two business days after you receive a simplified prospectus or Fund Facts document, or
- Cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
